

Godfather Gundogs Boarding For Training Policies and Procedures

Reservations and enrollment: Kennel hours are 8AM – 5PM, Monday – Saturday. For a fee, special in town pick or drop-off can be arranged at the parking lot of Cabela's Lone Tree.

Please call anytime during regular business hour to make a reservation. You may drop off your dog any time before noon on the day of enrollment. If it is your dog's first visit, please fill out the 2nd page to ensure a speedy check-In. To make a reservation we require deposit of \$200. This deposit is refundable up to 48 hours before enrollment. The balance is due at the time of drop-off, with bird fee tally at the end of each period.

Check-Out: In case the stay extant over the 30day period prorated daily rate apply. We are not open to the public on these holidays but pick up on these days may be arranged with advance notice and a service fee may apply. All fees must be paid in full at the time of check out.

Short Term : Short term stay is \$30 per day + birds

Vaccinations:

All dogs aboard must meet our vaccination requirements. A copy of vaccination records should accompany at drop off or may be emailed to us at godfathergundog@yahoo.com , proof of your dog's vaccination will be kept on file. We prefer vaccination records be emailed ahead of the time for a faster enrollment.

- DHLPP: Initial puppy shots required, booster thereafter every three years.
- Rabies: At 24 weeks of age, thereafter as required by law.
- Bordatella: annual and 5 day prior to boarding. (Following your vets recommendation as per the vaccine used.)

Collars and Personal Items: All dogs are fitted with a quality leather collar during their stay for easy identification and training purposes. **We are not responsible for damages to personal items.** We do not accept any stuffed toys or bedding. You may leave one durable chew toy. Godfather GunDogs cannot guarantee any personal items will be returned, please don't bring items that are irreplaceable. Please do not leave leashes at drop off, only a flat collar may be left on your dog.

Feeding: If you prefer NOT to modify your dog's current diet, you will need to provide food for the entire stay. This is recommended for the dogs that are here for short term (10 days or less) stay. Please label the food container with your dog's name. Please be sure to tell us at check-In if your dog(s) has food allergy or any other special feeding requirements.

Co-mingle: _____ please initial here if you allow your dogs to share the same run while its here for training.

Medication: We are happy to administer any medications your dog requires. Please make disclosure at time of drop off that your dog require medication. Medications must be clearly labeled with your dogs name, veterinarian contact info, and dosage. There is no charge for administer medication with the exception of medicated baths. We reserve the right to wash any dog that shows evidence of fleas or ticks at the owner's expense of \$30 per treatment. In these rare instances, you will be notified in advance if treatment of such is required. We also reserve the right to groom your dog (long coated) if it's required for field training.

Veterinary Care Policy: We agree to exercise our duties and take reasonable care of your pet. We assume no liability for loss or damage from disease, death, escape, theft, fire, injury to person, other pets or property by your pet. In case of illness or emergency medical attention, we reserve the right to transport the animal for veterinarian attention at the dog owner's expense including a \$65 trip charge. We use **Dusty Plains Animal Clinic** as the primary service provider. All medical expenses are the responsibility of the dog owner. Require by the State of Colorado, please state how you would like treat the remains in case of death _____

Training aid: We provide the most ethical practice in our training approach. However, some of the gears used in our program are known as rectification tools in animal behavior by the State of Colorado. Therefore, it is required by law to have a signed approval before we can incorporate these apparatus in to the daily training. Please initial or sing below to grant your permission.
